# Diploma of Early Childhood Education and Care

# **COURSE OVERVIEW**

- This qualification reflects the role of early childhood educators who are responsible for designing and implementing curriculum in early childhood education and care services. In doing so they work toimplement an approved learning framework within the requirements of the Education and Care Services National Regulations and the National Quality Standard.
- At least 50 per cent of the educators who are required to meet the relevant educator to child ratios for the service must have, or be actively working towards, at least an approved diploma level education and care qualification. A family day care co-ordinator must have an approved diploma level education and care qualification.
- This course is fully accredited nationally recognised training.







# **COURSE ENTRY REQUIREMENTS**

- There are no formal entry requirements for this course, however it is expected that you would be working in the industry and potentially have completed CHC30113 Certificate III in Early Childhood Education and Care or equivalent. It would also be expected that you have a genuine interest in early childhood development and working with children and that you can study self paced and undertake research tasks and project work.
- Be aware that working in this industry and with children will require you to obtain a National Police Check and a NSW Working with Children check prior to commencing employment. Other States and Territories outside NSW have similar guidelines and if you move around Australia it is advisable to check with local licensing authorities.
- Be aware also that most care facilities and education centres will require that workers and educators are physically fit and emotionally capable of working in the environment. This also means that workers do not have a pre-existing medical condition or a communicable disease that may put the health and safety of the children and other staff at risk.

#### **DURATION & STRUCTURE**

- The course combines face to face classroom based learning with workplace based practical placement and assessment. You will have over 18 months to complete the program. Depending on your commitment to study and industry experience, the program may becompleted earlier. You will be required to complete work away from class in your own time and you must complete 240 hours of mandatory work placement with children of different ages. We encourage you to find your own placement in a location that is convenient and we will assist with the process. Prior to enrolment students will complete a Language, Literacy and Numeracy test and be offered the opportunity to apply for Recognition of Prior Learning.
- You will be given all course materials and detailed information about assessment requirements and assessment submission.
   Students will attend two face to face session each week with their trainer.
