

## **CERTIFICATE IV IN ACCOUNTING AND BOOKKEEPING**

#### **COURSE OVERVIEW**

- This course is a nationally recognised qualification suitable for anyone wishing to operate as a bookkeeper or junior accountant in Australia. This includes those wishing to work or already working as a contract bookkeeper, employees performing the role of a bookkeeper in an organisation, as well
- as individuals wishing to receive training to be able to undertake a bookkeeping role to move up in their present
- ACSE will also consider applications from clients wishing to gain employment (new entrants) in accounting and bookkeeping and it is anticipated that this will be a significant proportion of the overall client cohort.

### **COURSE ENTRY REQUIREMENTS**

- There are no formal pre-requisites in the training package for course entry, however ACSE sets a number of its own entry requirements:
- Year 11 or equivalent, or Certificate III in a related field.
- Candidates must demonstrate Language, Literacy and Numeracy skills in line with AQF qualification level demands. Each candidate will undergo an LLN assessment prior to enrolment.
- Candidates that are wanting to become a licenced BAS Accountant, they have an additional requirements of:
- To complete at least 40% of the assessment for the entire course under some form of independent supervision
- Candidates that are NOT wanting to become licensed BAS Accountants they do not need to complete any assessments from this course under independent supervision (i.e. no work placement required)
- Candidates must also have access to:
- A PC or equivalent capable of processing and operating MYOB
- Internet connection
- A copy of MYOB and MS Office with MS Excel. Preferably MS Office 2010 or later and Windows 10 at a minimum.

#### **DURATION & STRUCTURE**

- This course as specifically an online course.
- The duration of the course is 12 months self-paced, including all learning and assessment activities. However, it is anticipated that the course length will vary with regard to individual client's level of expertise and time dedicated to study.
- As a guide, given the total number of units in the program is 13, students should aim to complete and be assessed in 1 unit per month. To do this, students will be required to study at least 15 hours a week or 60 hours a month.
