COURSE ENTRY REQUIREMENTS

- There are no formal pre-requisites in the training package for course entry, however ACSE sets a number of its own entry requirements.
- Be aged 18 years or over
- Candidates must demonstrate Language, Literacy and Numeracy skills in line with AQF qualification level. ACSE will conduct an LLN Test before enrolment.
- All students will be required to have completed the unit HLTAID004 Provide an emergency first aid response in an education and care setting before starting vocational placement.

Workplace Entry Requirments

- The candidate must be able to fulfill the work placement requirements of the course in a regulated education and care service facility. Work placement requirements will be discussed with all candidates' pre-enrolment. ACSE will organise work placement through its network with Early Childhood Education and Care Providers as well as Family Day Care Providers.
- Have a National Criminal Police Check and Working with Children Check prior to the mandatory vocational placement of this course.
- Have a reasonable level of fitness to cope with standing, lifting, bending, twisting and reaching
- Are physically, mentally and emotionally healthy to respond appropriately to personal needs
- Candidates must also have access to:
- A PC or equivalent running or capable of running Microsoft Windows 2010 and Microsoft Office 2010 and above.
- Internet connection
